Deed Restriction Reminders

There was some requests for clarification regarding Deed Restriction #12 Walls, Fences and Hedges No walls, fence or hedge shall be erected or maintained nearer to the front lot line that the walls of the dwelling existing on such lot. No side or rear fence, wall or hedge shall be more than (6) feet high. No chain link fence or wire fence type construction shall be permitted on any lot. Any wall, fence or hedge erected as a protective screening on a lot by first shall pass ownership with title to the property and it shall be the owner's responsibility to maintain said protective screening.

The interpretation of this that I received is, Any hedges or shrubs on sides or rear of home that are being used as a protective screening or barrier between neighbors shall not be more than (6) feet tall. If property is sold then barrier, shrubs and or hedges used as protective screening becomes responsibility of new owner to maintain.

Deed Restriction #15 has been brought to the boards attention and requested that it be enforced.

Signs, Advertisements, Billboards

No sign, advertisement, or billboard or advertising structure of any kind other than a normal "For Sale" sign not exceeding 5 square feet may be erected or maintained on any lot in said subdivision. First or it's assignee will have the right to remove any such sign, advertisement or billboard or structure which is placed on the said lot and in doing so shall not be subject to liability of trespass or other sort in the connection therewith or arising with such removal.

Therefore if you have signs on your property other than a "For Sale" sign please remove them promptly. We will be leaving violation notices for any signs that are not removed.

The OCV Directors board met with our HOA attorney to verify the process that we must follow regarding violation notices. Deed Restriction #14 states that you have 10 days to rectify any violation(s).

First Notice will be taped to your front door in which you will have 10 days to rectify. Second Notice will be mailed to your residence with a tracking number. Again, you will have 10 days to rectify any violation(s).

In the event items are not rectified after the second notice and the 10 days have expired, no meaningful contact has been received from resident at that property the tracking number will be turned over to the attorney, a file will be opened and all further contact will be between the resident and the attorney. All legal fees will be assessed
