Deed Restrictions Monthly Report / Topic for February 2021

The OCV Community Association, Inc. (HOA) identifies and advises property owners and residents of Deed Restriction violations within Oak Creek Village. The purpose of the deed restrictions is to keep property values up and provided for all residents safety. The Oak Creek Village deed restrictions are recorded and promulgate such that the documented reservations, restrictions, covenants, and easements to the use, occupancy and conveyance of all lots in said Oak Creek Village. In other words deed restrictions apply to all properties and when you bought your property the deed restrictions became part of your contract and you accepted and agreed to abide by them. If you receive a deed restrictions violation notice and have a concern the notice has provided instructions on how to address your concern to the HOA.

Deed restrictions identified 22 violations violations for month of January. Out of the 22 violations 13 have been corrected nine are still pending.

The HOA has authorized the association's attorney to proceed with a deed restrictions lawsuit for a trailer being stored in the driveway. We also authorized the association's attorney to proceed and issue two demand letters. One for inoperable vehicles and the other for trailer being stored in the driveway. To be clear in accordance with article 9 of the Oak Creek Village deed restrictions no utility trailers, boat trailers, boats, travel trailers, inoperative automobiles, campers, or vehicles of any kind are to be semi-permanently or permanently stored in the public street right-of-way or on driveways. If stored they must be stored out of the public view.

The HOA has directed two property owners to cease and deist all construction and cont.on page 4

For December 2020, revenue was above budget by \$928 primarily due to higher than budgeted Security Receipts income. Expenses were lower than budget by \$10,718 was mainly due to timing of depreciation expense.

Transaction Report

We had our normal operating expenses in the month of December.

Additional Notes:

Our 2021 Maintenance Fee of \$327 was approved at the November 2020 meeting and was mailed out the first week of December and was due at the beginning of January 2021. If it has not been paid it is past due and fees and interest will be added to it until paid.

Our 2021 Security Fee being collected on the water bill in the amount of \$30.50 was approved at the November meeting and will be sent to Bammel UD for the March 2021 bill as April is when the annual contract for Security renews and that bill is due by 20th of March.

architectural design changes being made to their property as they did not get approval for the changes from the HOAArchitectural Control Board. Along with the unapproved changes both of the property owners were making structural and elevation changes that requires Harris County building permit. The HOA informed and verified with Harris County Engineering that permits were not pulled. To be clear any and all outside architectural or elevation changes to the property front or back must be approved by the Architectural Control Board in writing. If you are not sure ask as the HOA can require you to remove or modify the change at your own expense and that can include past changes made by the homeowner that does not have documented HOA approval.

The HOA exercised the self-help clause as allowed in the deed restrictions article 14 and hired a lawn service to clean up the lawn and driveway area of one property. The cost of the service has been assessed against the homeowner's maintenance account and constitutes a statuary lean against the property.

All of the properties in Oak Creek Village are designated for single family residential use only and can only be occupied by family members. Please do not rent rooms out to non-family members as this allows for extra traffic and is a direct violation of article 2.

Most property owners have taken the time to clean up their lawn and the street curb in front of their property of leaves and pine needles. If you have not taken the time to clean your property please do or expect a violation notice letter. This action on your part will help prevent the storm system from flooding and backing up and I am sure it will make your neighbors happy and make the development look nice.

You currently pay for back door trash pick-up of normal residential garbage. Any other trash that is put on the curb can only be placed out the day before garbage service pick up. All cans must be removed from the curb after service pick up and stored out of public view. Accumulation of garbage on the curb on non-trash service days is not permitted and it allows

for vermin and other animals to make a mess and also makes the neighborhood look unsightly. Accumulation or storage of house hold items and garbage on balconies and breezeways that are visible from public view is not permitted. Please clean up any balconies and breezeways accumulations.



plants can be salvaged. First and foremost, do not prune them. It's not clear if all cold weather has passed, and pruning will encourage new growth and make the plant even more susceptible to frost and freeze damage. Instead, give yourself time to assess the damage.

Here are a few things to watch for during the recovery period:

Tropical plants that appear dead may come back from the ground or develop new growth from the stems. Once spring arrives, you can prune all dead material above the new growth. Woody plants are resilient. Plants that had buds or new growth before a freeze are usually healthy and can survive a freeze. They will usually flush out another set of leaves on their own. The buds of flowering plants and trees may sustain damage during icy weather, so expect smaller flower or fruit yields. Prune dead palm fronds in the spring.

Although dead, dry plant material should be left until spring, remove soft or mushy leaves and stems immediately to reduce the risk of disease. If you cannot tell what is dead, then leave it for a few weeks. For more information, check out Care of Freeze-Damaged Plants by Texas A&M AgriLife Extension.
