

OCV PRESIDENT'S LETTER

Dear Friends and Neighbors,

This month I would like to revisit GARBAGE! We pay a little extra each month for the guys to go to your back door to get your household garbage. Put it just outside your fence if you have one, or near your back door if you don't. We do this so that we don't have trash cans looking ugly all over the village lawns and falling into the street. Your yard waste and large items should be put at the curb. Tree and shrub branches should be tied together and be no more than 4 feet in length. If you have a really large item, you should call J&S to make arrangements. If you put your yard waste in a trash can at the curb, the new guys may think that's all you have, and miss your household garbage. Another problem we have had forever is corner houses. If your house faces a street different from the one your garage faces, for some unknown reason they miss your garbage if you leave it by your garage. I am tired of this and I have discussed it with Mr. J&S, who assures me that they will be told to look for it and pick it up. So, will you please leave it by your garage? If at any time they miss your garbage, call them. If it is after hours, or they don't answer, call me. They have gotten much better at answering the phone and returning calls.

The other side of the coin on this is deed restriction 14. This includes trash cans. Except on Tuesdays and Fridays, trash cans are to be stored out of public view. This is why you see homes with half fences at the side of the driveway. Please comply. As our area becomes more urban in character, it is especially important that we make every effort to keep our village looking neat and cared-for. I would also like to remind you that our deputies say this is the safest subdivision in the 1960 area. Be proud, but don't leave good stuff in your unlocked car.

One other thing. As many of you know, one of our residents had his garage explode recently due to a leak in a propane tank. He is in the hospital with 2nd and 3rd degree burns. Please be careful, although this has nothing to do with electricity, it reminded me that our homes are over 40 years old. It is very important to have an electrician check your electrical box. They wear out and can cause a fire, like the one next to me several years ago that burned down my fence and oak tree and broke my bedroom windows. It is expensive to have these boxes replaced, but cheaper than dealing with a fire. If you don't know an electrician, call me.

We are lucky to have had a reasonably cool summer, up to now, and September is coming soon, as

Bammel Utility District Landscaping Committee

Bammel Utility District hired a landscape architect to help them develop a landscaping plan for the water plant located behind the OCV clubhouse and pool, following the completion of the gas pipeline project. In an effort to provide a coordinated plan for the entire OCV Park and surrounding area, Bammel authorized their Secretary, Alan Kaniss, to create a committee of community leaders to provide insight into the needs of the various stakeholders. Funded entirely by Bammel the committee meets monthly to share ideas with the architect.

The committee met for the second time on August 18th and has provided Mr. Murr with a wish list of upgrades to the park area for consideration. Some of the initial ideas included additional parking at the clubhouse, a sprinkler system, a redesign of the playground, landscaping of the lot between the pool and the water plant and a walking trail within the greenbelt.

While funding has NOT been identified, the committee is hopeful that a coordinated landscaping approach will generate conversation between the key constituents within OCV leading to a multi-year plan of action to upgrade the look of the community.

Initial drawings and plans will be presented to the OCV HOA during their October Board meeting. Following input from the HOA it is envisioned a Town Hall meeting will occur during the month of November.

DEED RESTRICTIONS COMMITTEE UPDATE

The Deed Restrictions Committee want to personally thank all of the residents who have be kind enough to take care of any issues regarding their property after receiving a "card card". We are very grateful for your attention to these concerns. However, we have had some backlash as to some of the concerns that are listed on our care cards. We are going to address just those concerns to inform our residents that these Policies/Guidelines were recorded along with others regarding flag display; rain barrels; religious door and/or entryway displays; political signs; trash containers; storage of automobiles, boats, trailers and other vehicles. These Policies/Guidelines were approved by a majority vote of the Board of Directors of the OCV Community Association and recorded on December 21, 2011 with the County Clerk's Office of Harris County, Texas. If you wish, you can go online with the Clerk's Office to verify. The Policies/Guidelines are Amendments to our Deed Restrictions.

Window Air Conditioner ("AC") Units

No external window air conditioner units are allowed; except as follows: subject to being approved after submission to the Deed Restrictions Committee, window AC units may be allowed in the back of the house below fence height if not visible from any street; portable AC units with low profile exhaust that do not extend beyond the window frame may be approved after submission to the Committee.

Yard Ornaments and Lawn Furniture

Holiday ornaments are allowed during holiday seasons. They may be installed one month prior to the holiday and must be removed one month after the holiday. [Note: Holiday ornaments are exempt from the next two guidelines for height and number]. Any front and side yard ornaments may not exceed to 36 in. in height. Front and side yard ornaments if 24 in. or less in height are restricted to a maximum of six. Plastic ornaments are not allowed. Ornament must be of a color that is consistent with house trim or a neutral/natural color. Concrete, metal, or wrought iron benches not on a patio or deck are considered lawn ornaments. Lawn furniture is not allowed to remain overnight within any front or side lot or common area.

Portable Basketball Goals

Portable basketball goals are allowed in Oak Creek Village. Rules regulating portable basketball goals are as follows: Any portable basketball equipment must be "commercial construction" and must not be significantly altered from its original condition. Basketball nets must be maintained in a neat and orderly fashion and be replaced when frayed or broken. The backboard must also be maintained. It must be commercially manufactured out of material which will not weather, warp or disintegrate. At no time will the basketball goal be place in the street or curb in that public transportation/traffic will be hindered. In special instances with approval of the board the basketball goal may be placed up to the curb for play on the street in low traffic areas such as a cul-de-sac. The basketball goal will only be allowed to remain in that position for a 48 hr. period. Owner is reminded they are still responsible for damage to neighbor's property and cars parked on the street. When not in use a portable basketball goal must be stored in the garage or on the side of the garage on its side. If the portable basketball goal requires stabilization care should be used as to what will be used. Masonry block may be use, but such items as wheel rims, tires etc. are not allowed. The use of portable basketball goal will be allowed from sunrise to sunset. The Committee urges owners to keep in mind the right of their neighbors when engaging in play with their basketball goals and respect the property, safety and creation of noise nuisance to those around the owner.

All of these policies/guidelines were put in place in order to maintain a subdivision that all residents are proud of and increase our home values. Always know that the Committee will continue to be vigilant in our efforts. Thank you everyone for your support.

OAK CREEK VILLAGE COMMUNITY ASSOCIATION BOARD OF DIRECTORS MEETING MINUTES

AUGUST 12, 2014

The meeting was called to order by President Sharon Kuester at 7:40 p.m. Board members present were Sharon, Ron Halk, Lloyd Bratton, Tim Cooley, A. J. Salinas and Jon Whisler. Residents attending were Dan W. Goodale, Jeanette B. Fritsche II, Carol Barziza, Marilyn Bogle, Janet P. Deitsch, Bonnie Babcock, Lou Bernard, Bill Taylor and Josh and Jaci Marley.

The minutes of the July 8, 2014 meeting were approved as corrected. Ron Halk's name was left out although his report was included.

The meeting was preceded by a detailed presentation by Dan Linehan who supplied plans and costs for the design of the new monuments proposed for the entrances of Oak Creek Village. There was a lengthy discussion by resident committee members and board members with the conclusion that it would be necessary to revise some of the plans.

REPORTS

Maintenance – Written report read and approved. Ron suggested changing our park and pool area to long-life LED lights for our floods, etc. around the pool and clubhouse.

Security – Lloyd reported our 3 shift security was resulting in a safer flow of traffic in OCV. Residents mentioned that they had noticed some school busses traveling fairly fast on our streets. Lloyd recommended writing down the bus numbers and calling Spring ISD's Transportation Department to report them. He said that the school districts take speeding busses very seriously. Our electronic 'Speeder Signs' are on their way to OCV. Report approved.

Architectural Control – Tim reported a 'quiet' month.

Deed Restrictions – The OCV H.O.A. Deed Restriction Committee is up and running. The committee consists of ten volunteers and the Director of Deed Restrictions. The Oak Creek community neighborhood has been divided into sections with specific committee members responsible for each section. The members will be responsible for distributing courtesy cards, letters, and bringing to the attention of the board areas of concern thru the Deed Restrictions Director. Only the members of the committee will be authorized to distribute courtesy cards and letters to residents about Deed Restriction concerns.

The committee will also be instituting a new program to thank residents for doing a tremendous job of maintaining their residence. This will be done thru "Thank You/Appreciation" courtesy cards.

It is hoped that residents will become aware that we appreciate the great job that they are doing to maintain the standard that we all strive for in our neighborhood.

AJ also mentioned that our website needed to update some of the more recent legal restrictions imposed on Homeowner Associations by Texas Legislation.

Treasury – Written reports read and approved.

WATCH OUT FOR "OVER-WATERING." We all realize that in the fall and winter months daylight hours shorten and the intensity of the sun decreases. This means that lawns and landscaping require less water. What some folks fail to realize, though, is that over-watering under these fall/winter conditions can do as much harm to lawns and landscaping as a lack of adequate watering during spring and summer. October is a good month to begin reducing the amount of watering to only what is needed by dormant, or soon to be dormant, grass and plants. Remember that plants still need some water. If you see wilting or lack of luster in leaves or blades of grass, give the plants a drink. Just don't overdo it.


